Ownership. The Technology is the sole property of the Company. The User acknowledges and agrees that the Technology, including all modifications, improvements, and derivatives thereof, shall remain the property of the Company.

Restrictions on Use. The User shall not use the Technology or any part thereof without the prior written permission of the Company. The User acknowledges that any unauthorized use of the Technology may cause irreparable harm to the Company and that the Company shall be entitled to seek injunctive relief to prevent such unauthorized use.

Penalties. Any violation of this Agreement may result in penalties of up to \$500,000 USD. In addition, the Company shall be entitled to seek any and all remedies available at law or in equity.

Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the UAE, without giving effect to its conflicts of law principles.

Dispute Resolution. Any disputes arising out of or related to this Agreement shall be resolved exclusively through arbitration in the UAE. The decision of the arbitrator shall be final and binding on the parties and may be entered as a judgment in any court of competent jurisdiction.

Entire Agreement. This Agreement constitutes the entire agreement between the parties and supersedes all prior understandings and agreements between them relating to the subject matter hereof.
